History of the Foundation

Sedbergh School Foundation was founded as a separate charity in 2001 to raise funds to assist the School in its ambition to be the best boarding school in the north of England.

Over the past 15 years or so it has contributed towards the School's great success with record pupil numbers, an excellent Prep School at Casterton and outstanding pupil achievements.

The Foundation and its Trustees have raised over £10m to provide scholarships and bursaries, new laboratories and classroom facilities, refurbish boarding houses, fund the purchase of sports equipment and building of sports pavilions, creating the Thornely Music Studio and funding the new design and technology workshop at Casterton amongst many other smaller projects.

The Next Five Years

The demands on the Foundation will continue to increase as the School looks to ensure it remains at the top in a very competitive environment. The development of the new school in China, the opportunities for supporters to invest in the property portfolio, the new Sports Centre and fitness suite are testament to the Governors determination to achieve their ambitions



As the School has grown in number so has the number of pupils from abroad and the number of alumni who now live and work abroad has similarly increased with globalisation and increased opportunities for young graduates to work throughout the world. This has led to the Foundation identifying opportunities for those parents, former parents and alumni living overseas to support the Foundation tax efficiently.
